## **Notice to Creditors, Debtors, Asset Holders & Interested Persons**

All persons holding assets belonging to bankrupts or who have relevant information on the assets and affairs of bankrupts should furnish the information on such assets and their location to:

- the Official Assignee if the bankrupts are under the Official Assignee's administration;
- the respective Private Trustee if the bankrupts are under the administration of a Private Trustee.

All secured creditors should notify the appointed Trustee in Bankruptcy of their intention to continue claiming interest pursuant to s 327(4) of the Insolvency, Restructuring and Dissolution Act 2018.
